You pay a contractor a deposit and they never show up to do the work.




You bought a new home and the seller didn't disclose there was a mold problem.

In some of the most common disputes, as shown below, more than **90%** of the claims paid are for plaintiff issues.<sup>1</sup>


**Defendant**
